1. **RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT.**

3. **SECTION VIII -SPECIAL CONDITIONS OF CONTRACT**

The Warranty provided shall be;

- a) 20,000 km for the following repair categories.i.e. Engine overhaul gearbox, and differential unit overhaul for vehicles.
- b) 500 operating hours or one year whichever comes first for Plant Equipment.
