Confirm we can also not have JV of companies not in the engineering trade Eg JV between Pharmacy and Registered contractor.	Any JV must adhere to clause 3.5 and will be subjected to the evaluation process as set in the tender document.
If a manufacturer qualifies to offer their bid directly and also authorize other suppliers/bidders to quote products from their factory.	Yes. A manufacturer can bid directly and also authorize other bidders to quote from their factory. This is acceptable as long as the manufacturer is not entering into a joint venture.
