ADDENDUM NO. 1 TO THE TENDER NO. KP1/9A.1A/OT/004/20-21 FOR SUPPLY, INSTALLATION AND COMMISSIONING OF 3NO. 500KVA ENCLOSED DIESEL GENERATORS AT MFANGANO AND BARAGOI POWER STATIONS.

The following amendments are made to the specified provisions of the Tender document.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect.

2. CLARIFICATION MADE TO SKETCHES TO THE INTERESTED BIDDERS.

The following responses are made to clarifications sought on various issues on the tender document.

Item	Question	KPLC Response
1.	We seek clarification for Item no.7 of the GTP, requiring the engine design to have each piston having a separate cylinder head.	Each piston MUST have a separate cylinder head and bidders must confirm by attaching Catalogue that illustrates this requirement, clearly highlighting these features on the catalogue.

2	<p>On page 76– The condition for Engine should be such that each piston must have a separate cylinder head.</p> <p>On page 153 – Mandatory requirement number 7. The design of the engine should be such that each piston MUST have a separate cylinder head.</p> <p>Perkins Engines do not have this specifications. The Perkins Engines have 6 cylinder in line with one cylinder head for the Engine. Can I proceed and provide this offer ?</p>	<p>The specifications and provisions of the tender still stand as they are. Bidders are advised to read instructions on tender requirements and provisions of all specifications thoroughly and comply accordingly.</p>
