EXPRESSION OF INTEREST (EOI)
FOR PROVISION OF SECURITY CONSULTANCY SERVICES -
TENDER NO. KPI/9AA-2/PT/52/CA&CS/14-15

Kenya Power's mandate is to purchase, transmit, distribute and retail electricity throughout Kenya. In order to fulfill this mandate, the company has put in place a large transmission and distribution system that it requires to adequately secure so as to guarantee availability and stability of electricity supply to its customers.

The purpose of this Expression of Interest (EOI) is to solicit applications from suitably qualified and competent providers of security consultancy services for comprehensive multi-sites security risk survey and recommendation's for the design for the security enhancement program for the company.

ELIGIBILITY CRITERIA

Interested consultants should express their interest by providing information/documents in support of their competence, ability and suitability as follows:

1. Ten (10) years proven track record in providing security consultancy services for critical energy infrastructure.
2. Proven experience in providing security consultancy services (in addition to proven experience in Kenya) in completing at least one Integrated Security Management System (ISMS) project for a large organisation with a value of at least 15,000,000 USD in the last 5 (five) years, subject to Kenya Revenue Authority (KRA) verification or equivalent in the country of domicile.
3. Must submit proof of three (3) security consultancy services provided in critical energy infrastructure, one of which must be in electrical energy production, transmission and distribution infrastructure. Proof shall be submitted in the form of reference letters and certificates of completion of the work done.
4. Ten (10) minimum experience in Physical Security as well as Blast Mitigation field.
5. Relevant experience and knowledge in multinational security standards and expertise.
6. Provide a written proposal that demonstrates capability and experience to provide Kenya Power with an enterprise Integrated Security Management System, which will enable Kenya Power to improve its security effectiveness management. The proposal should include:
 - (i) Written capability statement written on not more than 8 single sided A4 pages (strictly font 12)
 - (ii) Abridged CVs (strictly not more than two single-sided A4 pages of font 12) of a maximum of 5 key personnel
7. Interested consultants MUST submit copies of the following documents:
 - (a) Evidence of Incorporation/Registration in the country of domicile.
 - (b) Valid Tax Compliance Certificate (Local bidders) subject to KRA Verification or equivalent statutory document for international bidders.
 - (c) PIN Certificate (Local bidders) or equivalent from country of origin
8. The consultant may express interest in association with other firm(s).

Duly submitted EOIs will be opened promptly after closing and prospective bidders or their representatives are welcome to witness the opening in the **Stima Plaza Auditorium, Kolobot Road, Parklands, Nairobi**.

Save when responding to Kenya Power's request for a clarification, prospective bidders shall not contact or discuss any aspect of their EOI with Kenya Power after closing date before receipt of an official letter inviting further proposals or communicating regret as applicable. Any such contact shall lead to disqualification of the prospective consultant.

Any canvassing misrepresentation, giving of false information, fraudulent or corrupt activity will lead to automatic disqualification and liability to debarment from public procurement.
