**ADDENDUM NO. I TO THE TENDER NO. KP1/9A.2/OT/56/PJT/18-19 FOR PROVISION OF LABOUR AND TRANSPORT CONSTRUCTION SERVICES**

***The following clarifications are made to the specified provisions of the Tender document.***

**1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT**

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

**2. CLARIFICATIONS**

The following responses are made to clarification sought on various issues in the tender document and shall be deemed to form the addendum;

**a) SECTION III - INSTRUCTIONS TO TENDERERS (ITT)**

3.40 **Joint Venture-** under 3.40.1 (a) the word **agreement** was misspelled as **(8ement )** and the statement should read as :- 3.40.1 (a) The Tender Form and in case of a successful tender, the Contract **agreement** Form, shall be signed so as to be legally binding on all partners of the joint venture.

**b) SECTION V (B) - SUBMISSION OF RATES FOR 66KV WORKS IN AREAS WHERE 66KV NETWORK IS CURRENTLY UNAVAILABLE**

Bidders are hereby notified that, submitted rates for 66kV works (**new connections** or **Maintenance** under Tables 2 & 4) shall only be evaluated for selected Regions and associated FFBUs that have 66kV network currently. The following are regions with existing 66kV network:-

- Nairobi South
- Nairobi North
- Nairobi West
- North Eastern

**c) SECTION VI- EVALUATION CRITERIA**

- i. 6.1 Preliminary evaluation table part 1 under 6.1.0 - **Correct order and Format of submitted documents**, bidders are notified that the purpose of this section is to guide them in submitting their bids and shall not form part of evaluation criteria.
- ii. 6.1 Preliminary evaluation table part 1 under 6.1.3 - **submission of Tax compliance certificate**, bidders who encounter challenges in renewing their Tax compliance before closure of tender, shall provide evidence from KRA (attach the error message together with expired Tax compliance). However, successful bidders shall be required to submit Valid Tax compliance before commencement of work.
- iii. 6.3 financial evaluation part III under 6.3.1 (a)- **submission of Audited financial statements**, bidders whose companies or firms that are registered or incorporated within the **last Two calendar years** of date of the tender document, they should submit certified copies of Bank statements covering a period of at least six (6) months prior to the date of the tender document. The copies should be certified by the issuing bank. The certification should be original).

**d) SECTION VII- STATEMENT OF TENDERER FORM**

Bidders are notified that statement of tenderer form is different from tender form. Both forms (tender form page 91 and statement of tenderer form page 75) **MUST** be filled and submitted as required in the tender document.

**e) SECTION XXIV-ENGINEER ESTIMATES**

Bidders are notified to ignore the provided engineers estimates which do not form part of this tender.

**f) TENDER CLOSING DATE**

The tender closing date remain **26<sup>th</sup> June 2019 at 10:00 am.**

All other terms and conditions remain as per the Principal Tender Document (PTD).
