# RE: ADDENDUM (NO. 1) TO THE TENDER NO. KP1/9A.3/OT/03/20-21 FOR THE SUPPLY OF OVERHEAD FUSE CUTOUT 400A.

#### 1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT.

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document (PTD).

#### 2. AMENDMENTS

Provisions of the Principal Tender Document are hereby amended as follows;

#### a) Eligible Tenderers (Clause 3.3.1 of the Appendix to ITT);

Old: This is a national Tender open to Citizen Contractors only.

New: This Tender is now open to <u>local</u> contractors only.

#### b) Tender Validity:

Old: Notes on the Tender Security template indicates that the Tender validity as one hundred and twenty (120) days.

New: The Tender validity period displayed on the notes to the Tender Security template has been realigned with the Appendix to ITT to read <u>one hundred and eighty (180) days.</u>

#### c) Evaluation Criteria;

Old: Requirement for the bidders to submit a Manufacturer's Authorization was omitted in the evaluation criteria.

New: Clause 6.2.1.4 has been amended to make it a mandatory requirement. The Manufacturer's Authorization Template is herewith attached as provided for in the PTD.

### 3. CLARIFICATIONS

The following is the KPLC response to the sought clarifications;

Question: The highest voltage is 36KV. Then the total creepage distance should

be 25x36=900mm. But it required 1200mm. Which one should we

follow?

Answer: The creepage distance is for very heavy pollution level IV as per IEC

60815. 31mm/kV. (1200mm is appropriate)
