1. The Government of the Republic of Kenya has received a Credit from the International Development Association (IDA) towards the cost of the Kenya Electricity Modernization Project (KEMP). It is intended that part of the proceeds of this Credit will be applied to eligible payments under the contract for Supply of Distribution Transformers.
2. The Kenya Power and Lighting Company Limited now invites sealed bids from eligible bidders for: **KP1/6E.2/PT/4/16/A50: Distribution Transformers**. Details of the Distribution Transformers being procured are as tabulated below:

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, published by the Bank in January 2011 (Revised July 2014) "Procurement Guidelines", and is open to all eligible bidders as defined in the Procurement Guidelines.
