RE: ADDENDUM NO. 1 TO THE TENDER NO. KP1/9AA-2/PT/06/14-15 FOR SUPPLY OF NEW TRANSFORMER OIL.

Please refer to the above Tender.

Following the pre-bid meeting held in our Auditorium at Stima Plaza Nairobi on 19th May, 2014, upon enquiry from prospective bidders thereat, and, at our own initiative we make the following clarifications and amendments to the Principal Tender Document (*hereinafter abbreviated as the PTD*) for Supply of Transformer Oil 2014.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the PTD shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read and construed as part of the PTD.

2. SECTION III – APPENDIX TO INSTRUCTIONS TO TENDERERS (THE APPENDIX)

- i) **Clause 3.37.2 Award of Framework Contract-** The award criteria is hereby amended to read that: **“Award shall be made to the lowest bidder per lot. If a bidder is lowest in all lots ,they shall be awarded the first two lots with the highest quantities and the last lot shall be re-tendered”**.

3. **SECTION VI- EVALUATION CRETERIA**

Clause 6.1.4.2- Item number (d) which requires bidders to provide names with full contact as well as physical addresses of previous customers of similar goods and reference letters from at least four (4) previous customers has been withdrawn and will not be evaluated.

4. **SECTION III- INSTRUCTIONS TO TENDERERS**

Clause 3.19 – Validity of Tenders – Tenders shall remain valid for 90 days and not 120 days as indicated in this clause. Bidders shall ensure that their bid security is valid 30 days beyond the validity of the tender.(i.e 120 days)

Clause 3.43- Monopolies and Restrictive Trade Practices has been withdrawn from the tender document.

5. **CLARIFICATION ON TYPE OF TENDER**

Bidders are advised that the tender for New Transformer Oil is a National Tender and not an International Tender as advertised in the newspaper advert of 20th May,2014.

7. **MISSING PAGES IN THE TECHNICAL SPECIFICATIONS FOR NEW TRANSFORMER OIL**

The specifications for New Transformer Oil appearing in the website, have several pages missing. The missing pages are 1,3,5,7,9 & 11, the specifications bearing all pages has been uploaded in the website.

8. **DEADLINE FOR SUBMISSION OF TENDER.**

The tender closing date remains **11th June, 2014 at 10.00 a.m**

Tenders must be received by the procuring entity not later than **10.00a.m at Stima Plaza Auditorium**. The procuring entity will open the bids immediately thereafter on the same day in the **auditorium Stima Plaza**.

All other terms and conditions remain as per the Principal Tender Document.
