Clauses 6.1.8 and 6.1.9 and 6.1.10 are amended to read as follows:

Submission of the following;

**a) For Goods Manufactured in Kenya**

- i) Submission of copies of relevant type test certificates and their Reports or Test Certificate from KEBS. This is no longer a requirement in this tender
- ii) Valid KEBS Diamond Mark of Quality Certificate or KEBS Standardization Mark Certificate for goods manufactured in Kenya. This is no longer a requirement in this tender
- ii) Manufacturers Authorization or if a manufacturer state so
- iii) Manufacturer's warranty or own warranty
- iv) Manufacturer's Drawings or own drawings
- v) Schedule of Guaranteed Technical Particulars as per tender specifications.

**b) For Goods Manufactured outside Kenya**

- i) Copies of relevant type test certificates and their Reports or Test Certificates
  - ii) The accreditation certificate for the testing laboratory to ISO/ IEC 17025.
  - iii) Relevant valid ISO 9001 certification
  - iv) Manufacturers Authorization
  - v) Manufacturer's warranty
  - vi) Catalogues and or Bronchures and or Manufacturer's drawings
- All the other terms and conditions remain as per the tender document.

As per clause 3.15.1 in Appendix to Instructions to Tenderers, Samples are not required.

**Bidders are required to note that samples will be required for the bidders who shall be notified of the award before the execution of the contract with KPLC.**
