ADDENDUM (I) TO TENDER NO. KP1/9AA-2/PT/17-NM/14-15 FOR PROVISION OF LIVE LINE TRAINING SERVICES

The following amendments are made to the specified provisions of the Tender document for provision of Live Line Training Services. Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

1. SECTION VI - TECHNICAL EVALUATION CRITERIA

- a. Clause 6.2.1 b bidders are advised that they **shall not** be required to provide manufacturer's or principal authorization.
- b. Clause 6.6.2 on experience, bidders should note that it refers to the trainer/trainer experience in the live line training. The detailed CV of the trainer/trainers shall be submitted. The team to be trained shall comprise of 5 No. Artisans / craftsmen + 1 No. Supervisory staff at the level of a Technician / Engineer

2. <u>SECTION IV – SCHEDULE OF REQUIREMENTS</u>

Bidders are required to note that the proposed commencement date is April 2015 and not February 2015 as indicated.

3. <u>SECTION VIII - SPECIAL CONDITIONS OF PAYMENT</u>

Clause 7.11.1 Payment shall be made in partials depending on the schedules of training submitted by the successful bidder.

4. <u>LIST OF TOOLS & ACCESSORIES FOR EACH TEAM</u>

List of tools & accessories procured is attached from Hubbell (USA). KPLC is also procuring 8 No. High lift platforms (46kv insulation) & 3 No. Digger Derricks.

5. <u>CLARIFICATION FROM BIDDERS QUERIES</u>

Bidders are required to note the following calcifications arising out of the bidders queries.

- i. Bidders should note that Kenya Power has no teams presently trained on distribution live line work.
- ii. It is a requirement in the tender that bidders shall provide a suitable training schedule and filed supervision.
- iii. The successful tenderer shall be required to provide a suitable High Voltage Live line manual and work procedures
- iv. Training shall be on Glove and Barrier method for voltages up to 33kv, and stick methods for 66kv.
- v. Training shall include up skilling in Live low voltage lines
- vi. Training to be conducted at the Kenya Power training school in Nairobi. The tenderer is to come up with a training schedule for the 12 teams.
- vii. Public holidays in Kenya are; January 1 New year day, Good Friday, Easter & Easter Monday, May 1 Labour day, June 1 Madaraka day, Eid al Fitr (end of Ramadhan), October 20 Mashujaa day, December 12 Jamhuri day, December 25 Christmas day and December 26 boxing day.
- viii. Bidders are required to note that visits to bidders are not a requirement during the tendering process. However, subject to clause 3.35, Kenya Power may at its discretion, conduct visits to the winning bidder to confirm their capacity to offer the training services.
- ix. Bid security shall be from a Kenyan Bank or institution located in Kenya. Foreign bidders are advised to make arrangement with Kenyan banks to raise the tender security. Further the tender security should strictly in the format provided in the tender document.

- x. There is no tender requirement that International bidders need not work with a Kenyan registered firm. However bidders who wish to enter into a joint venture can do so as per clause 3.3 of the tender document.
- xi. Prices should be inclusive of all taxes and levies payable in Kenya and presented in the format shown on section V page 29 of the tender document.

6. TENDER CLOSING DATE

The tender closing date remains on **04.12.2014** as indicated in the tender document at 10.00am.

All the other terms and conditions remain as per the tender document.
