### 3. <u>CLARIFICATION ON THE SPECIFICATIONS FOR THE ORDINARY BLUE</u> <u>OVERALL</u>

It is clarified that sub section 4.2.8.5.5 (b) on the overall specifications will not apply to this tender on the overall requirement.

#### 3. QUANTITIES FOR THE INSULATING GLOVES

Please note that quantities of the insulating gloves are clarified below.

- 1. Class 2 Insulating gloves 11kV is 750 pairs
- 2. Class 4 Insulating gloves 33kV is 250 pairs
