2.	What is the format of bid security required?	The tender security shall be in the form of a Bank guarantee issued by Banks Licensed by the Central Bank of Kenya). The Tender security should be in the format provided in the tender document.
3.	Will there be application of preferences as indicated in the instructions to tenderers.	Preferences shall not be applicable for this tender.
4.	In the case of a joint venture, who shall be responsible for submission of the bid	The tender requires the bid to be submitted by all the firms forming the joint venture. Bidders are required to refer to the Instructions to bidders regarding the procedures required for joint venture participation.
5	Please clarify of Eligible Tenderers.	Only APA (Association of Practitioners in Advertising) registered advertising agencies are eligible or those registered in associations of its equivalence in their countries in cases of foreign bidders. In case of a joint venture, the Lead Partner or Contractor must be a member of APA or any internationally recognized advertising association.

7.	Can bidders be allowed to submit the CDs for the pitch presentation at the time of the presentation	Yes, Bidders who will be found to meet the minimum required score in the technical evaluation shall be invited to present the pitch. Bidders will submit the CDS of the pitch during presentation.
