ADDENDUM (i) TO TENDER NO. KP1/9AA-2/PT/08/13-14 - FOR PROTECTIVE CLOTHING, SAFETY WEAR, GEAR AND MEASURED UNIFORM. NATIONAL TENDER FOR ALL BIDDERS.

The following clarifications are made to the specified provisions of the Tender document for the above mentioned tender.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT.

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

2. SPECIFICATIONS

a) **BOOT ARMY OIL RESISTANT**

The boots referred to in schedule of requirements page 35 as 'boot army oil resistant' codes 113966,113962, 113963, 113964 113965 & 113961 is the 'safety boot' described in specification for personal protective equipment part 2: footwear on page 4.

b) KAUNDA SUIT

The Kaunda suit as described in specification measured uniform clause 4.3.2 shall be delivered in sets of two.

c) WELDING HELMET

Bidders are requested to note that branding of helmets (Kenya Power logo) has been waived However, the bidder shall submit a drawing to scale (with the tender) showing how the helmet will be branded. For the successful bidder a sample of branded helmet shall be submitted to KPLC for approval before manufacture.

d) SAMPLE VIEWING

There are no available samples to view except for the African Attire and KPLC requirements are as indicated in the specifications. Where available the specifications include approved designs, otherwise bidders to quote as per specifications.

Sample for the African attire can be viewed at 3rd floor stima plaza procurement office & the designs are as per the attached photo to this addendum.

3. DEADLINE FOR SUBMISSION OF TENDER.

The tender closing date has been changed from 6th June, 2014 to 17th June, 2014 due to public request.

Tenders must be received by the procuring entity not later than 17th June 2014 at 10.00a.m. The procuring entity will open the bids thereafter on the same day in the auditorium Stima Plaza.

All the other terms and conditions remain as per the tender document.








