**RE: ADDENDUM NO. 2 TO THE TENDER NO. KP1/9AA-3/PT/84/14-15
FOR SUPPLY DISTRIBUTION TRANSFORMERS (LOCAL MANUFACTURERS ONLY)**

Please refer to the above Tender.

We make the following clarifications and amendments to the Principal Tender Document (*hereinafter abbreviated as the PTD*) for the Supply of Distribution Transformers dated 7th May, 2015.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the PTD shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read and construed as part of the PTD.

2. AMMENDMENT TO SECTION III INSTRUCTIONS TO TENDERERS

Clause 3.17.2 on Warranty is amended to read:

“The Warranty will remain valid for five (5) year after the goods, or any portion thereof as the case may be, have been delivered to the final destination indicated in the contract”

3. AMMENDMENT TO SECTION III APPENDIX TO INSTRUCTIONS TO TENDERERS

a) Item 5 Clause 3.13.3 (c) and (d) documents of evidence of eligibility, the particulars of Appendix item (ii) is not applicable to local manufacturers and is therefore deleted.

b) Item 8 – clause 3.17.2 period of warranty, the warranty period is five (5) years from the date of delivery.

4. AMMENDMENT TO SECTION VII GENERAL CONDITIONS OF CONTRACT

Clause 7.26.2 on Warranty is amended to read:

“The Warranty will remain valid for five (5) year after the goods, or any portion thereof as the case may be, have been delivered to the final destination indicated in the contract”

5. **AMMENDMENT TO SECTION VIII SPECIAL CONDITIONS OF CONTRACT**

Clause 7.26.2 on Warranty is amended to read:

“The Warranty will remain valid for five (5) year after the goods, or any portion thereof as the case may be, have been delivered to the final destination indicated in the contract”

AMMENDMENT TO SECTION XIIB MANUFACTURERS WARRANTY FORM

The period of Warranty indicated in the manufacturer’s Warranty form is amended to read five (5 years). The amended Manufacturer’s Warranty form is attached as Appendix 1.

6. **CLOSING DATE**

The closing date remains the same **2nd July, 2015 at 10.00am.**

All other terms and conditions remain as per the Principal Tender Document (PTD).
