ADDENDUM (2) TO TENDER NO. KP1/9AA-2/PT/35 - ID/14-15/JNM FOR PROVISION OF CIVIL & BUILDING WORKS AT RABAI 220 AND 132KV SUBSTATION

The following amendments are made to the specified provisions of the Tender document for Provision of Civil & Building Works at Rabai 220 and 132kv substation. Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

Following the pre bid visit onsite, the following issues are brought to the attention of the bidder

1. DRAWINGS

Following the pre bid visit and the agreement onsite on the material day bidders are notified of attachment of the following drawings: The following drawings have been attached

2. REVISION OF BILLS OF QUANTITIES (BOQ)

Bidders are required to note the revision of the Bills of Quantities as follows:-

- Transformer foundations are 2 not 3
- Relocation of road and retaining wall removed from preliminary
- NCA statutory fees added on the approval item on preliminary
- Detail for the masonry retaining wall revised
- Foundation bolts for gantries supplied by the contractor but all other bolts supplied by client

3. EVALUATION CRITERIA CLAUSE 6.4

Bidders are also required to note the revision of the clause 6.4 where the lowest evaluated bidder shall be determined by the weighted formula as indicated below:-

The evaluation of the responsive bids will take into account technical factors, in addition to cost factors. Weighted Bid Score (B) will be calculated for each responsive bid using the following formula, which permits a comprehensive assessment of the bid price and the technical merits of each bid:

$$B \equiv \frac{C_{low}}{C} X + \frac{T}{T_{high}} (1 - X)$$

Where:

C = Total Price for the bidder being evaluated

C low = the lowest Evaluated Bid Price among

Responsive bids

T = the total Technical Score awarded to the bidder being evaluated

 T_{high} = the Technical Score achieved by the bid that scored

Highest among all responsive bids

X = weight for the Price which is **0.25**

4. AWARD OF CONTRACT CLAUSE 3.43

The award criteria has been changed based on the outcome of the weighted formula. The firm that scores the highest Evaluated Bid Score (B) will be eligible for the award of contract.

2. TENDER CLOSING DATE

The tender closing date remains the same at 14.04.2015 at 10.0 a.m. All the other terms and conditions remain as per the tender document.
