Introduction

Objective

Scope of Work

- Levels of service quality and programmes offered by Kenya Power and Lighting Company limited in relation to safety and health
- Safety and health service delivery systems and propose recommendations for improvements.

 An assessment report with recommendations will be expected at the end of the assignment in both hard and soft copies.
