ADDENDUM (I): TO TENDER NO. KP1/9AA-2/OT/89/CA&CS/16-17 FOR PREQUALIFICATION FOR DESIGN, SUPPLY, INSTALLATION, INTEGRATION, TESTING & COMMISSIONING OF AN INTEGRATED SECURITY SYSTEM FOR KPLC PILOT PROJECT.

Arising from queries received from participating bidders, the following amendments and clarifications are made to the specified provisions of the Tender document for Prequalification For Design, Supply, Installation, Integration, Testing & Commissioning of an Integrated Security System for KPLC Pilot Project.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the principal Tender Document shall continue to be in full force and effect. The provisions of this addendum shall be deemed to have been incorporated in and shall read as part of the principal Tender Document.

2. SECTION V, ITEM 5: REQUIREMENT FOR A PIN CERTIFICATE

Whereas it is a mandatory requirement to submit a Pin certificate for the Company, bidders are advised that if the same is not applicable in their countries, then they can provide an equivalent or a statement to that effect.

3. <u>SECTION V, ITEM 7: AUDITED FINANCIAL STATEMENTS FOR YEAR 2014, 2015</u> <u>& 2016</u>

Whereas our requirement is for 2014, 2015 and 2016, it is possible that year 2016 financial statement may not be audited. Bidders whose statements are not audited can provide the unaudited 2016 accounts and issue a statement of deviation to that effect.

4. <u>SECTION V -TABLE B ITEM 6 ON RELATIONSHIP BETWWEN A FOREIGN BIDER AND A LOCAL REGISTERED COMPANY</u>

The wording in this item have been amended to read as follows: -

A Foreign Bidder must sign a letter of intent to sign a contract with a local registered company that will provide the local support, commissioning, and maintenance of the ISS during the Defects Liability Period/Warranty Period.

5. SECTION V -TABLE C ITEM 1 ON RELATIONSHIP BETWWEN A JOINT VENTURE AND A LOCAL REGISTERED COMPANY

The wording in this item have been amended to read as follows: -

A JV must sign a letter of intent to sign a contract with a local registered company that will provide the local support, commissioning, and maintenance of the ISS during the Defects Liability Period/Warranty

All the other terms and conditions remain as per the tender document.
