Clause:-3.11.3.

For the avoidance of doubt, Tenderers shall quote on all inclusive basis, including Value Added Tax (V.A.T)

However when keying in the Total Price per Lot in the system (Portal) you will be required to key in VAT EXCLUSIVE, as prescribed during the Pre bid meeting.

No other basis shall be accepted for evaluation, award or otherwise.

3.11.4 Tender prices to be submitted (quoted) by the Tenderer shall remain fixed for the contract duration.

3. **CLOSING DATE**

Tender closing date has been changed from 10th November 2016, to 29th November, 2016 at 10.00 am due to the clarifications cited during the Pre-bid Meeting
