Alternatively, a letter of intent to execute a JV Agreement in the event of a successful proposal shall be signed by all members and submitted with the Expression of Interest, together

with a copy of the proposed Agreement.

Evaluation of the expression of interests will be based on the following criteria, for which respective

- minimum thresholds for eligibility are also mentioned:

   Successful completion of similar types of contracts in an English speaking country. Minimum:
  - 2 contracts.
  - Experience in supervision and management contracts (owners Engineer contracts) each with a
    value of 3 million Euros as a minimum in transmission, medium distribution lines and distribution
    substation. Minimum 2 contracts.
  - Experience in project supervision and management of similar projects in the region (Africa).
     Minimum: 1 project.
  - Annual average turnover over the last 3 years. Minimum average: 1.5 million Euros.
  - Signature of the covenant of integrity is required.
  - ISO 9001 certification is required.

Among the submitted applications, The Kenya Power & Lighting Company Limited (KPLC) will shortlist on the basis of the above listed criteria a maximum of 6 consultants, to whom the Request for Proposals to carry out the Services shall be sent.
