Please refer to the above Pre-Qualification Tender.

Upon enquiry from prospective bidders thereat, and, at our own initiative we make the following clarifications and amendments to the Principal Pre-qualification Tender Document (*hereinafter abbreviated as the PPTD*) for Pre-qualification of Labour & Transport Contractors (Local Liabilities Company's Only) dated March 2014.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the Principal Pre-Qualification Tender Document (*PPTD*) shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read and construed as part of the PPTD.

2. NUMBER AND NAME OF TENDER

3.1 Delete "*7th Floor*" and insert "*Tender Box Ground Floor*"

3.2 All other refernces to '*7th Floor*' wherever appearing in the PPTD are deemed amended to '*Tender Box Ground Floor*'.

4. SECTION I – INVITATION NOTICE, ITEM NO. 1.4; PAGE 6

4.1 Delete the entire clause and replace with the following:-

'Pre-Qualification tenders will be opened at 11 a.m. on 12th June 2014 in the presence of candidates or their represenatives who choose to attend at the Stima Club, Ruaraka, Nairobi.'

4.2 All other refernces to '*Auditorium – Stima Plaza*' wherever appearing in the PPTD are deemed amended to '*Stima Club, Ruaraka, Nairobi*'.

All other terms and conditions remain as per the PPTD. Whilst all care has been taken to ensure the numbering and identification of various paragraphs, clauses and contents in the PPTD and the Addendum issued herein correspond and are in the correct sequential manner, any errors arising therefrom will be deemed inconsequential to the extent that they do not cause any confusion and are not misleading.
