- 1. Tenderers must indicate the dimensions and total weight of the poles in their bid documents.
- 2. For purposes of this Tender all the 10M poles belong to diameter class 140 mm and 11M and 12 M to diameter 180mm measured at the top.
- 3. Bidders in the Youth and Women Category shall quote for a minimum of 500 poles whereas bidders in the category of people with disabilities shall be required to quote for a minimum of 250 poles. However, KPLC shall not be bound to award the minimum of 500 and 250 poles respectively to any successful Tenderer.
- 4. Tenderers shall quote the number of poles they can deliver per location as long as the total number of poles tendered for is not less than 500 and 250 poles as stated above.
- 5. All deliveries shall be made to KPLC stores or as otherwise indicated in accordance with the above Schedule.
- 6. The delivery period for this tender shall be from commencement date of the contract and be completed within Twelve (12) months from that date.
- 7. Any Tenderer who provides a delivery Schedule that is not consistent with the one above shall not be considered for further evaluation or award.
- 8. Successful bidders will be required to adhere to the delivery schedule. Roll overs from one batch to the next shall be considered a default in contract obligations, whose consequences shall be addressed in accordance with the provisions relating to the contract at clauses 7.22 and 7.23 of the General Conditions of Contract
