ADDENDUM NO. 2 TO THE TENDER NO. KP1/9AA-2/PT/04/14-15 FOR SUPPLY OF TREATED POWER DISTRIBUTION WOOD POLES FOR THE YOUTH, WOMEN & DISADVANTAGED GROUPS

The following amendments are made to the specified provisions of the Tender document for Supply of Treated Wood Power Distribution for Youth, Women & disadvantaged groups dated May 2014.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect.

The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

2. **SECTION VI- Preliminary Evaluation**

Clause 6.1.12 shall be amended to allow a manufacturer to authorize a maximum of five (5) bidders per lot.

3. Part II of Technical Evaluation (Table 1)

Bidders shall be allowed to provide a single business permit as evidence of office or premise availability.

4. SECTION III – APPENDIX TO INSTRUCTIONS TO TENDERERS

Bidders are required to note amendments on **Note No. 11. Note No. (e) shall now read as follows;** "(Subject to (d) above, graduation in (d) shall be adopted as long as the variation in price with the lowest bidder is not more than 10% until all the poles listed in this Tender document are exhausted.

5. SECTION VI – SUMMARY OF EVALUATION PROCESS

a) <u>CLAUSE 6.1 – PRELIMINARY EVALUATION</u>

Bidders are required to take note of amendments made to the Preliminary evaluation as follows;

a) Clause 6.1.4.2:- The Names of full contacts as well as physical addresses of previous customers of similar goods and reference shall now not be mandatory but will be part of the Scoring Criteria.

6. SECTION IX - MANUFACTURER'S WARRANTY FORM (82)

Bidders are required to note that the Warranty shall be valid for 25 years from date of manufacture.

7. SECTION IX – TENDER FORM (Page 66)

Bidders are required to note and include the total tendered amount (inclusive of all taxes) in the space provided on the Tender form.

8. DEADLINE FOR SUBMISSION OF TENDER

The closing date for the tender has now changed from 12th June 2014. The tender shall now close on **Wednesday 25th June 2014** at **10.00 a.m.** The tenders shall be opened immediately thereafter at **Kenya Powers Training School** located at Ruaraka, Nairobi next to Utalii Hotel, Nairobi.

Bidders are required to note that the venue for submission of Bids remains the same as indicated in the tender document.

All the other terms and conditions remain as per the tender document.
