## ADDENDUM TO THE TENDER NO. KP1/9AA-3/OT/36/15-16 FOR SUPPLY OF UNIVERSAL CLAMPS AND STREET LIGHTING BRACKETS (LOCAL BIDDERS ONLY)

The following amendments are made to the specified provisions of the Tender document for Supply of Universal Clamps and Street Lighting Brackets (Local Bidders Only) dated 19th January 2016.

## 1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect.

The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

## 2. AWARD CRITERIA

Bidders are required to take note of a requirement in Appendix to Instruction to Tenderers section (Item no.18 regarding Award of Contract on page 32 of the tender document) which states that:

"Award shall be on an item by item basis to the technically compliant and lowest evaluated bidder. No bidder shall be awarded more than one Lot of similar items"

Bidders are required to note that the mentioned section of the award criteria has been revised so as to read as follows:

"Award shall be on an item by item basis to the lowest evaluated bidder per Lot. No bidder shall be awarded more than one lot of similar items, unless the price of the other bidders exceed 5% of the lowest evaluated bidder.

NOTE: If a bidder qualifies as the lowest evaluated bidder for the same item in more than one lot, they shall be awarded that item in the lot with the highest quantity. The subsequent lots shall be awarded to the 2<sup>nd</sup> and 3<sup>rd</sup> lowest bidders in that order provided that the price difference between the lowest evaluated bidder in that lot and the price of the 2<sup>nd</sup> & 3<sup>rd</sup> lowest evaluated bidders shall not exceed 5%. If the price of the 2<sup>nd</sup> and 3<sup>rd</sup> lowest evaluated bidders exceeds 5% of the price of the lowest evaluated bidder, the item shall be awarded to the lowest evaluated bidder".

## 3. <u>DEADLINE FOR SUBMISSION OF TENDER</u>

The bidders are required to take note that the tender closing date has been extended to Wednesday 24th February 2016 at 10.00 a.m.

All the other terms and conditions remain as per the tender document.
