ADDENDUM NO. 1 TO THE TENDER NO. KP1/9A.2/OT/016/ICT/24-25 FOR PROCUREMENT OF FIBER OPTIC TOOLS AND EQUIPMENT

The following clarifications are made to the specified provisions of the Tender document.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

2. AMENDMENT OF ITT 40 AWARD CRITERIA (TDS)

The award criteria has been amended as follows;

Mode of award shall be on item basis per lot in accordance with the following:

- i. Award shall be to the bidder(s) with the lowest evaluated price per item. However, no bidder will be awarded the same item in more than one delivery location.
- ii. If a bidder emerges the lowest in more than one location they will be awarded the item with highest value / quantity. Consequently, the subsequent item(s) will be allocated based on the highest value and lowest price per item until all the items are allocated provided that the price of the subsequent lowest bidder is within the prevailing market price subject to (iii) and (iv) below.
- iii. If there is no other qualified subsequent bidder for the unallocated item(s), the award will revert to the bidder with the lowest evaluated price per item, notwithstanding (i) above. In case of a tie, the award will be split amongst the bidders subject to consideration of ready stock.
- iv. KPLC shall also take into consideration the following:
 - Timely Delivery as per delivery capacity and satisfactory performance. Any bidder with more than 50% overdue KPLC order balances on previous KPLC contracts will not be considered for award.
 - Bidders with ready stock that can be delivered within 7 days will be considered for award provided that their prices are competitive

3. TENDER CLOSING DATE

The tender closing date has been extended from 31st January 2025 to 7th February 2025 at 10:00am.

All other terms and conditions remain as per the Principal Tender Document (PTD)
