Please refer to the above Tender.

The following clarifications and amendments are made to the Principal Tender Document of Procurement of Data Leak-Loss Prevention Solution.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the PTD shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read and construed as part of the PTD.

2. CLARIFICATION ON TENDER REQUIREMENTS

- (I) Bidder attention is brought to the cover page , invitation to tender (ITT) & tender data sheet (TDS) of the tender document in which the tender description is as shown below:
- (II) The number of on-premise data centres shall be two(2) Data Centres (Production & Disaster Recover Centre)
- (III) The number and location of cloud-based data centres (Azure, Google, AWS etc) shall be two (2) (Safaricom & Microsoft). More Cloud migration may happen in the future
- (IV) The number of server operating systems (Windows, Unix & Linux) installed at each site and each site has servers running Microsoft Windows Server, Linux (Redhat, Ubuntu, Oracle Linux, Rocky Linux) & Unix (Solaris, SunOS, FreeBSD)
- (V) The number of existing workstations shall have a range 7000 End Points as indicated on the tender document.
- (VI) The number of end users shall be 10,100 mainly on-prem and the license shall be for one (1) year.
- (VII) The data stores shall be : SharePoint, One Drive, File Servers, Google Drive, Database Servers, On-Prem Backup and Archival storage and any other
- (VIII) Note that M365 API scanning & document tagging shall be required.
- (IX) The identity provider shall be Active Directory (primary), Synchronizing to Azure AD for M365 and KPLC currently have single sign on for the cloud apps

- (X) The number of domains are kplc.local , kplc.co.ke and the email provider is Hybrid (Exchange on-Prem and M365)
- (XI) The relevant cloud providers for KPLC currently are Microsoft, Safaricom and Konza but not restricted to the two.
- (XII) The SIEM is in use are FortiSIEM & open source e.g., Wazuh
